No. LAC/Acq/185/Mohali/18546-B-Whereas it appears to the Governor of Punjab that land is likely to be required to be taken by the Government, at the public expenses, for the public purpose, namely for "Setting up of IT Park in Sector-101, Mohali, in village Dhurali, Tehsil and District Mohali.

It is hereby notified that land in the locality described below is likely to be required for the above purpose.

The notification is made under provisions of Section-4 of the Land Acquisition Act, 1894.

In exercise of the powers conferred by the aforesaid section, the Governor of Punjab is pleased to authorize the officers for the time being engaged in undertaking with their servants and workmen to enter upon and survey any land in the locality and do all other acts required or permitted by that section.

Any person interested who has any objection to the acquisition of any land in the locality may within 30 days of publication of this notification give in writing before the Collector Land Acquisition, Department of Industries and Commerce, Punjab, Sector-17, Bays Building, Sector-17, Chandigarh.




