No. Infra/Vacant Place/IFP Malout/Muktsar/ 147/ 21568-B In partial modification of the notification issued vide No. Infra/Vacant Place/IFP Malout/Muktsar/147/13148-A, dated 24.08.2010, relating to rehabilitation of the Existing units/entrepreneurs/workshop holders/ancillary shops and services affected due to construction of road for National Highway and beautification plan of Malout City, District Muktsar, the provision (i) of the scheme for allotment of industrial plots available in the Focal Point, Malout, District Muktsar may be read as under:-

- i. Existing units/entrepreneurs/workshop holders/ancillary shops and services affected due to the construction of road for National Highway and beautification plan of Malout City duly identified and verified by a committee under the chairmanship of Deputy Commissioner, Muktsar, and comprising of General Manager, District Industries Centre, Muktsar Sub Divisional Magistrate, Malout, District Town Planner, Muktsar and Estate Officer Punjab Small Industries & Export Corporation, Chandigarh shall be eligible to apply for the allotment of industrial plots in the Focal Point Malout, District Muktsar. The Committee will assess the eligibility of such applicants on the basis of permanent SSI registration with General Manager, District Industries Centre, Muktsar and/or electricity bills etc.
